- note 3 McNeil Field enhancements (\$60,000 with Ball Assn.), Cricket field (\$5,000 with Cricket assn.)
- note 4 annual additions to sidewalk/trail/bike pathways, exact locations to be determined (new deal funding)
- note 5 core area development including streetscape improvements, cost sharing of new streets to downtown standard etc. (new deal funding, includes \$50,000 no
- note 6 replacement of front mount tractor for sport fields (\$22,000), front loader blade for tractor (\$2500), water truck (\$15,000, \$5000 to be allocated to Utility via
- note 7 wheel chair accessible door recreation(\$5000), heat pumps (\$6000), lobby redo (\$3000)
- note 8 no capital repairs/additions planned for 2008

- note 11 to continue the program of acquiring and displaying art to enhance the cultural aspect of the community
