WHEREAS the Georgetown Sewermain, Sundance Cove Sewermain, Lantz Subdivision Sewermain and Rankin Watermain extensions, have been selected for servicing in 2009 under the Building Canada Fund - Communities Component (BCFCC); and

WHEREAS the budget estimates for these projects are as follows:

Georgetown Road and Area Sewermain Extension \$605,000.00;
 Sundance Cove Sewermain Extension \$664,000.00;
 Lantz Subdivision Sewermain Extension \$420,000,00; and
 Rankin Subdivision Watermain Extension \$800,000.00.

BE IT RESOLVED that the Stratford Utility Corporation apply to the BCFCC program for the amount of \$2,489,000.00 needed to complete the above projects in 2009.

BE IT FURTHER RESOLVED that these projects be designated as priority numbers two, three, four and five respectively of the BCFCC projects applied for. In addition, Council understands and commits that it will be responsible for its' designated share of the eligible costs of the project, and will assume responsibility for any and all operating and maintenance costs resulting from the project.
