Mayor Steve Ogden called the Special Council Meeting to order at 9:00 a.m. and welcomed those who were viewing via social media, as well as those in attendance.

Mayor Ogden took a moment to acknowledge the land upon which we gather is the unceded territory of the Mi'Kmaq people, and we pay our respects to the indigenous Mi'Kmaq people of this territory past, present, and future.

# 3. Resolution PH020-21 TZ002-21 Leslie Hilton Home Occupation Text Amendment – Zoning and Development Bylaw #45 – Second Reading

Moved by Councillor Jill Burridge Seconded by Deputy Mayor Gary Clow

**WHEREAS** an application has been received from Lesli Hilton of 53 Marion Drive for an amendment to the Town of Stratford Zoning and Development Bylaw #45 to allow for a home occupation in a semi-detached dwelling. Currently, a home occupation is only allowed in a single dwelling; and

**WHEREAS** a public meeting was held on June 23, 2021, at 6:00 p.m. at the Stratford Emergency Services Centre. Due to the current COVID-19 gathering restrictions this public

meeting was limited to 50 people but was also live streamed for people to watch and residents were given until June 30, 2021, to submit their comments; and

**WHEREAS** as of the date this report was written, several comments have been received from the public on this application will all in favour of the proposed amendment.

**BE IT RESOLVED** that Bylaw #45-G, a bylaw to amend the Town of Stratford Zoning and Development Bylaw, Bylaw #45, be hereby read and approved a second time.

Councillor Gail MacDonald noted that the resolution doesn't state that the change is for all semi-detached dwellings – she felt it wasn't clear. She also didn't like the idea that the name and address of the person is in the resolution. The planning director explained the 'Be it Resolved' is the action and the bylaw explains that the change is for all semi-detached dwellings and no names or addresses are mentioned. Leslie Hilton's name and address are mentioned because she put forward an application for an amendment to the zoning and development bylaw.

5. Resolution PH022-21 - Town of Stratford, 101523 PEI Inc. and Farquharson Zoning and Development Bylaw #45 Text and Zoning Map Amendments Bylaw 45H - 2<sup>nd</sup> Reading

**WHEREAS** applications have been received from SJ Murphy Planning and Consulting on behalf of the Town of Stratford, Ian Dalton, 101523 PEI Inc, Paul and Robert Farquharson, and Jane Farquharson and Doug Crossman for amendments to the Town of Stratford Official Plan and the Zoning and Development Bylaw #45; and

**WHEREAS** the requested changes relating to the Community Campus properties also necessitate a text amendment to both the Official Plan and Zoning and Development Bylaw #45 to accommodate the potential range of proposed uses, including restaurants and lounges as secondary uses in the Public Service Institutional zone; and

**WHEREAS** some of the subject area was previously located within Town boundaries, resulting in a request for changes in designation and zoning for those portions, while other portions have recently been annexed into the Town, requiring a process to assign new designations and new zoning; and

**WHEREAS** a public meeting was held on June 23, 2021, and due to COVID-19 gathering restrictions for this public meeting were limited to 50 people but it was also live streamed for people to watch, and residents were given until June 30, 2021, to submit their comments and no comments were received on the proposed text amendments that were outlined by the Town Planner, and

**WHEREAS** Bylaw # 45H, a bylaw to amend the Town of Stratford Zoning and Development Bylaw #45, had received first reading at the July 14 Council Meeting;

**BE IT RESOLVED** that Bylaw # 45H, a bylaw to amend the Town of Stratford Zoning and Development Bylaw, Bylaw #45, be hereby read and approved a second time.

Mayor Ogden noted that it is very historic for Stratford to be at this point and to be in a position to purchase 170 plus acres of property. It was a long and arduous process to get to this point as there were a lot of parts to this transaction. Mayor
