This resolution bears the recommendation of the Planning & Heritage Committee as discussed at a meeting held on February 22nd, 2018

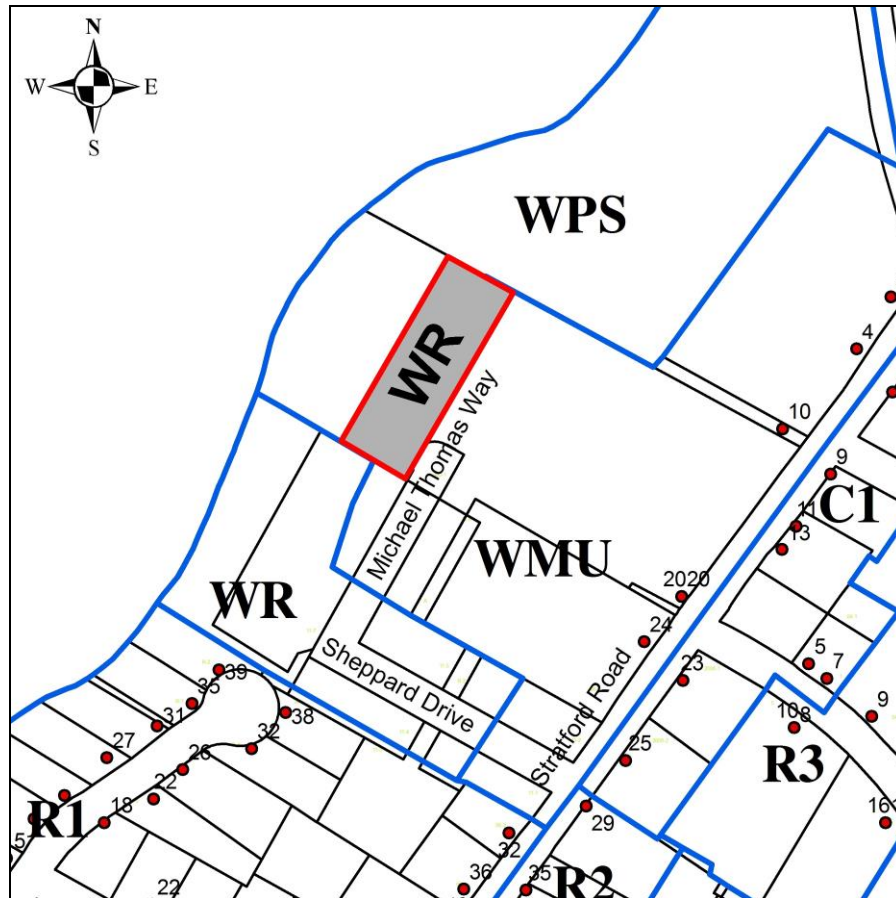

Bylaw # 29-G

A Bylaw to amend the Town of Stratford Zoning and Subdivision Control (Development) Bylaw, Bylaw #29 to change Schedule “A” Zoning Map.

BE IT ENACTED that a portion of parcel number 327973 be hereby designated as Waterfront Residential Zone (WR) in Schedule “A” the Zoning Map of the Town of Stratford Zoning and Subdivision Control (Development) Bylaw #29, as shown on the attached map, hereby excluding it from its former designation of Waterfront Mixed Use Zone (WMU) and Waterfront Public Space Zone (WPS).
