### f) Transit Report

Included in the meeting package. Councillor Gallant noted that we are now waiting for the official report on the regional transit study.

Councillor Gallant stated that the Citizens on Patrol report will also be included in future packages. Councillor Ogden asked how Citizens on Patrol compares to Neighbourhood Watch and Councillor Gallant replied that the Citizens on Parol is a group of volunteer residents who patrol the town on weekends, and if they see anything they feel warrants a call to the RCMP they call and report it. However, it is important to note that they do not get out of their car or intervene in any way.

Deputy Mayor Clow explained that the Neighbourhood Watch is a community program and the RCMP can oversee it and advise them, but the residents take ownership of it.

Mayor Dunphy noted that during his door to door campaign many residents expressed concern regarding a lot of safety issues such as speeding and street lights. Deputy Mayor Clow suggested inviting the RCMP to the next Committee of the Whole meeting for some discussion.

Councillor Ogden asked about the installation of stop signs and Councillor Gallant explained that stop signs are the responsibility of the province, and although we can put in requests, the final decision is made by the province.

## 16. ECONOMIC DEVELOPMENT COMMITTEE

### a) No Report

Mayor Dunphy noted that the committee members will be appointed in January and a meeting will be held shortly thereafter.

Mayor Dunphy noted that a service station, as well as a *House of Excellence* are slated to come to Stratford in the very near future, and this is good news for the Town.

### 18. OTHER COMMITTEES

### a) Stratford Seniors Complex

Councillor MacDonald noted that all units are occupied and things are going well at the complex. He noted that the new committee will hold their first meeting next week.

Mayor Dunphy asked about the waiting list for the complex and Councillor MacDonald replied that there are about 25 people on the waiting list, but noted that when a unit is vacant, we sometimes have to go down quite far on the list before we can fill it.

Mayor Dunphy stated that one of the needs that came forth when he was going door to door was affordable housing for seniors. Councillor MacDonald stated that he and Kim O'Connell met with a representative from CMHC and they were advised that there is no program to subsidize the housing once it is built. Mayor Dunphy stated that this is an issue he wants to keep on top of, as there may be possibilities we haven't yet considered.

### b) Land Acquisition Committee

No Report. Deputy Mayor Clow stated that we are in the process of getting together with Faye MacKinnon to try and purchase some land around the Town Centre.

### 20. OTHER BUSINESS

Deputy Mayor Clow noted that he attended the FPEIM annual meeting in Tignish, along with Councillor Ogden and Councillor MacDonald, and he would recommend that councillors view the presentations on the FPEIM website. He noted there is an orientation for new councillors, as well as a presentation on conflict of interest by Karen Campbell, who is the solicitor for the City of Charlottetown.
