1. <u>CALL TO ORDER</u>

Mayor Kevin Jenkins called the February 10, 2010 Regular Monthly Council Meeting to order at 7:30 p.m.

5. CARI REPORT

Ron Fisher gave a verbal report noting that CARI is playing host to the 2010 Canadian Open National Synchronized Swimming Championships being held April 28 to May 2. He also noted that CARI has commissioned HRA to do a salary review of key personnel.

6 CORRESPONDENCE

Included in the meeting package for Council to review is a list of all correspondence received since the last Council meeting.

There was some discussion on the cabinetry that will replace the coat racks in the front lobby, and Councillor Ross stated that he would like to be sure we have the new racks here before we tear out the old ones. Deputy Mayor McMillan stated that we are currently working to have replacement rolling racks made and we will try to coordinate the new cabinetry and the replacement coat racks as close together as possible.

7. MAYOR'S REPORT

Mayor Jenkins noted that both he and Councillor Griffin attended the FPEIM meeting and Councillor Griffin circulated a summary of the meeting to all of Council. Mayor Jenkins noted that he also circulated a summary of his meeting with Mayor Lee regarding the waste water.

9. PUBLIC WORKS AND PROPERTY

a) Report

Councillor Griffin gave a brief overview of her report noting that the committee is reviewing the paving needs in the Town and once the list has been completed and reviewed by the Committee of the Whole, it will be forwarded to the Provincial Department of Transportation and Public Works.

Councillor Griffin noted that it is time to renew the grass cutting and cleaning contracts and tenders will be going out soon.

Councillor Gallant stated that he knows this does not fall under our public works department, but he has received complaints about the snow clearing on the sidewalks of the Hillsborough Bridge. He noted that the sidewalks were not cleared properly following the last two storms. Councillor Gallant added that he did advise residents that it is the province who looks after this, but noted that if there is an opportunity, we should also relay the message.

10. STRATFORD UTILITY CORPORATION

a) Report

Included in the package for Council to review. Deputy Mayor McMillan noted that we did not have a quorum for our last meeting, but we did have a discussion meeting. She noted that we are continuing to search for a new well site and have moved to a new location on the Trans Canada Highway across from Clearview Estates.

Mayor Jenkins asked if there is a timeline for receiving the final report from ADI and Deputy Mayor McMillan replied that we are waiting for the City of Charlottetown to come back with some figures. Robert noted that he will follow up to keep things moving forward.

Councillor Clow asked about metering our water, and Deputy Mayor McMillan replied that this is something we have discussed in the past and we are going to conduct a metering study this year to determine the viability of installing meters. It was noted that apartment buildings in the Town are currently metered.

A complete written report was included in the package for Council to review. Councillor MacDonald gave a brief overview of the report noting that the Winter Carnival is being held February 25 to 28 and asked any councillors who are available to drop in and enjoy some of the events.
