1. CALL TO ORDER

Mayor Dunphy called the Regular Monthly Council Meeting to order at 7:43 p.m. and welcomed those in attendance.

Mayor Dunphy stated that Erin Clarke is filling in for our community engagement coordinator Wendy Watts who is on maternity leave.

2. APPROVAL OF THE AGENDA

Deputy Mayor Randy Cooper reiterated Mayor Dunphy's comments regarding the staff. He noted that the Levee keeps getting better each year thanks to the hard work of the staff.

9. CHIEF ADMINISTRATIVE OFFICER

Report included in the package. Robert noted that it has been quiet as there were no meetings held in December. He added that once the committees are appointed later in the agenda we will be back in full force.

10. INFRASTRUCTURE

a) Report

Mayor Dunphy stated that he is now chair of the Infrastructure Committee and thanked Jeremy in advance for his help as he takes over the role.

Waste Water Treatment Facility – the plant is running well. We are currently working with the federal and provincial governments on a long term solution for the facility and hope to have an answer by the end of January. Included in the package is a table with the average effluent results for the plant over the past year.

Inflow and Infiltration Study – the data collection is complete and we have some preliminary information regarding the collection. The report is still not complete, but we do have enough information to budget for some repairs in 2017.

Sidewalk Construction - we are currently in the process of designing the continuation of the Georgetown Road project for 2017.

Budget 2017 – the second draft of the budget has been presented to Council and we are in the process of reviewing the draft and making any required adjustments.

Metering Program - staff is currently in the process of preparing a tender for the purchase and installation of the meters for the 2017/2018,

Outdoor staff has been busy with interior repairs to some of our buildings and with snow removal. The Utility staff is busy completing winter maintenance on our systems. Utility staff did have to deal with a water main leak in the Reeves Estates Subdivision on January 1, 2017. The leak was fixed quickly and there was minimal disruption to the residents in the area.

Mayor Dunphy noted that the Christmas decorations this year were great and Councillor Clow agreed. It was noted that many positive comments were received on the decorations this year.

Mayor Dunphy stated that he is looking forward to working with the Infrastructure Committee over the next two years, and hopefully accomplishing some great things.

11. RECREATION, CULTURE AND EVENTS

a) Report

The report was included in the package for Council to review. Councillor MacDonald noted that the afterschool Arts and Crafts program was re-introduced and program and registration fees are identified in the winter program guide that was recently released to the public.

The Stratford Minor Basketball Association has stated league play for youth in grades 1 – 6. There are approximately 181 youth registered in five divisions and play will run until March.

The Bunbury Rink outdoor skating surface is up and running and staff is currently preparing the Pondside Park skating surface, and hopefully the weather will cooperate.

The month of December was extremely busy with special events. The staff and the Events Committee members hosted the children's Christmas party and the Town Levee. Both of these events were very well attended. Plans are underway for the upcoming winter carnival which will be held February 17 to 20. There will be a wide host of

activities offered again this year and a full itinerary will be released through local media, social media, retail, schools and the Town website.

The youth centre had a strong year in 2016. The average daily attendance was 18 youth, and there are 54 registered members. The 54 registered members have a combined total of 1249 volunteer hours with the youth centre and within the community.

Island artist Audrey Bunt was the guest instructional artist on December 8. This was the last meeting of the art club; the winter session began on January 10 and will finish March 14.

Councillor MacLean noted that the number of volunteer hours performed by the youth is very impressive. He asked that once the members leave the program do we keep in contact with them, and Joanne replied that some of them do come back and help us out.

Councillor Clow asked if we record the numbers of our walking track and Joanne replied that we do. It was also noted that the track is always very busy the first few weeks of January and then it drops off. Councillor MacDonald will get the numbers and bring them back to the next meeting.

Deputy Mayor Cooper stated that we are closing the books for 2016, and we are now working on the 2017 budget. All things are pointing that we will finish 2016 in the black and meet our debt reduction target.
