4. <u>PRESENTATIONS</u>

a) Presentation of Framed Henry Purdy Print "Tide Watch" to Marie O'Hanley

Deputy Mayor McMillan explained that there is a painting by Henry Purdy in the front office of the Town Centre, and we held a contest asking residents to submit suggestions for naming the painting. Marie O'Hanley was the winner with her submission of 'Tide Watch' and tonight we will present Ms. O'Hanley with a print of the painting. Scott Cudmore of the Arts and Culture Committee, and Deputy Mayor Sandy McMillan presented the painting to Ms. O'Hanley. Photographer Winston Maund was on hand to take photos of the presentation.

b) Presentation by Billy Ramsay to Water Conservation Calendar Winners

Mayor Jenkins - On behalf of Town Council, it is a great honour to welcome the grade five students from Glen Stewart Elementary School and their families who are here with us this evening. The vision of our Town "Stratford" is very clear "A Sustainable Community." The decision has been made, the framework is in place and we are well on our way to becoming a more sustainable place to live, work and play. It is not enough to have a vision alone. You see, we can have the seeds of sustainability, but in order for them to grow they must be planted somewhere, in someone. In order for these seeds to take root they must be cared for and watered regularly (but remember, when watering the seeds, to water in early morning or late evening because you can lose up to 50% through evaporation, and we don't want to waste any water).

The seeds must be planted in fertile ground, and the fertile ground must possess certain characteristics. It must be certain of its purpose. It must have a willingness to share its resources and it must be passionate about achieving its goal.

You students here today are the fertile ground in which the seeds have been planted. You were chosen to be here this evening because we know you can effect change. We believe that you can carry the message of Water Conservation better than anyone, and we want you to know that we believe in all of you.

Tonight we want to honour you for your achievement in winning the Water Conservation Calendar Art Contest. Your artwork sends the message loud and clear that conserving water is important. Along with your reward comes a great responsibility. We are counting on you to help in delivering this message. The message isn't just sharing with as many people as you can, although that is important, rather it is a style of life that you model in front of others that will have the greatest impact. It is a lifetime commitment of striving to change for the good of the environment in which we live. The result of your commitment will be far reaching, passing it on from generation to generation.

So Congratulations boys and girls for a job well done. We are very proud of you. As a way to honour you here this evening, we have for you a framed piece of your artwork. Each piece of artwork will represent a month in next year's school calendar. The calendars will be given out to every child at Glen Stewart School before the end of this school year.

As I call your name please come forward. Your winning artwork will be displayed on the overhead screen and Billy Ramsay and Deputy Mayor Sandy McMillan will present the winning artwork to the students.

c) Library Presentation

Librarian Jane McKinney introduced herself noting that she is the librarian at the Stratford Public Library. She noted that this is her annual visit and she would like to thank the town for the support they give the library such as utilities, maintenance promotion space in the town newsletter etc.

A copy of the annual statistics for the 2009 - 2010 was circulated and Ms. McKinney noted that since her last visit the library hours have increased from 18 per week to 30 per week, and she now has an assistant on Tuesday mornings to help with the book drop and mail delivery. She noted that we are now housing 2000 more books in the same space, so space is an issue. Ms. McKinney noted that the Confederation Centre Library has stepped in with some shelving units to help out until we are able to get a larger space. Don Scott, the chairman of the library board also extended his thanks to the town for all the support it has given the library.

Mayor Jenkins thanked Ms. McKinney for all her hard work noting that he has heard a lot of positive comments about the library.
