## b) Resolution CW014 - 2008 Stratford Kindergarten Spaces

Moved by Councillor Diane Griffin Seconded by Councillor Patrick Ross

**WHEREAS** the CHANCES Family Resource Centre on Mason Road runs a number of programs for Stratford and area children; and

**WHEREAS** CHANCES decided to start a Kindergarten program in 2008 to allow children who were in other CHANCES programs to stay at the same facility and avoid two transitions in two years when they would start Grade 1 at Glen Stewart School; and

**WHEREAS** the research shows that each transition can disrupt the learning potential of students; and

**WHEREAS** the Department of Education and Early Childhood Development has declined to provide public funding for the CHANCES Kindergarten program; and

**WHEREAS** we understand that there are approximately 110 students enrolled in Grade 1 at Glen Stewart School and only 60 publicly funded kindergarten spaces in the Stratford area and that there are unused funding allocations in other communities.

**BE IT RESOLVED** that a letter be sent to the Minister of Education and Early Childhood Development to request that the number of publicly funded kindergarten spaces in Stratford be increased to allow the CHANCES Kindergarten Program, and any other potential program in the Stratford area, equal access to publicly funded Kindergarten programs in their own community.

## 8. CHIEF ADMINISTRATIVE OFFICER

Included in the agenda package for Council to review. Robert briefly reviewed the report noting that there was an Economic Development meeting on Tuesday and Jacob Hemistra and a representative from CADC were in attendance to give an update on where they are with the proposed Stratford Towers.

## 9. PUBLIC WORKS

## a) Report

Included in the agenda package for Council to review. In Deputy Mayor MacDonald's absence, Councillor Griffin briefly reviewed the report. She noted that the trail that runs from MacLauchlan Drive to Bonivista Drive, and from Paget Cresent to Keppoch Road has been resurfaced. The trail along Mutch Drive was also resurfaced and is now wheelchair accessible.

Budget requests were also discussed and some of the requests will include funding for sidewalks, bikepaths and trails.

Councillor Griffin noted that surplus inventory was disposed of by a bid process, however, one item did not meet the reserve bid and will remain in the Town's inventory.

## 10. STRATFORD UTILITY CORPORATION

#### a) No Report

Councillor Ross noted that the committee didn't hold a regular meeting in November, but did hold a special meeting to discuss the regional water study. He noted that everyone was updated on this issue at the last Committee of the Whole meeting and added that the consultants will be looking after this for us.

Councillor Ross did note that there was a major watermain break on Friday, December 5 at the intersection of Kinlock Road and MacKinnon Drive, and with the quick action of staff, we were able to get things under control before the snow started.

Jeremy noted that the backup power at Pondside is very close to completion and we are hopeful that it will be up and running by the end of December. He also noted that the tender has been released for the wasterwater treatment upgrades.

Mayor Jenkins stated that he appreciated the good communication during the watermain break crisis and asked if we have an estimated cost for the repair, and Jeremy replied he believes it will be approximately \$30,000.

#### 11. <u>RECREATION REPORT</u>

#### a) Report

A complete written report was included in the agenda package for Council to review. In Councillor Clow's absence, Councillor McMillan gave a brief overview of the report noting that the Winter Carnival will be held February 26 to March 1. She also noted that there will be three free skates at the Pownal Rink for Town residents (dates included in the package).

Councillor McMillan noted that the Youth-Can-Do held a dance on November 21 and there were 288 youth in attendance.

Also included in the package is a list of all the events that took place over the past month.

## c) Resolution PH019-2008 Signage for Former Communities

Moved by Councillor Sandy McMillan Seconded by Councillor Emile Gallant

**WHEREAS** the Town of Stratford is committed to protect and maintain local history and heritage; and

*WHEREAS* part of that local history is the five former Communities: Southport, Bunbury, Keppoch-Kinlock, Battery Point and Crossroads; and

**WHEREAS** the Heritage Sub-Committee recommended these former Communities be re-identified by replacing a new sign at the entrance to each Community; and

**WHEREAS** the new signs would read "Welcome to Community Name "such as Bunbury" a Stratford Heritage Community."

**BE IT RESOLVED** that a new sign be erected at the entrance to each of the five former Communities to recognize their history in the Town.

spelling is two words.

#### c) Resolution PH021 - 2008 Wind Energy Policy Number 2008-PH-01

**WHEREAS** the Town of Stratford recognizes that accesses to variable renewal sources of energy for the generation of electricity will allow environmentally friendly energy to be produced in the town and reduce the amount of fossil fuel consumption; and

**WHEREAS** as the first Towns practice on Collaborative Planning, Councillors and Planning Staff invited all key stakeholders to collaborate in developing Stratford's Wind Energy Policy and Bylaw; and

**WHEREAS** an initial Public Meeting was held on June 14, 2008 followed by a series of Focus Group Meetings and discussions led to the identification of key elements and development of the 1<sup>st</sup> draft Policy; and

**WHEREAS** the draft of Stratford's Wind Energy Policy was discussed and revised in Planning board and Committee of the Whole meetings; and

**WHEREAS** on November 18, 2008 residents and interested parties were invited to attend a Public Meeting to view and comment on the Wind Energy Policy.

**BE IT RESOLVED** that the attached Wind Energy Policy, Policy #2008-PH-01 be hereby approved.

# d) Resolution PH022 - 2008 The Development Bylaw #29 - B (Part III) an Amendment to Development Bylaw #29 - 1<sup>st</sup> Reading

**WHEREAS** pursuant to the Provincial Planning Act and under Section 24 of the Development Bylaw, A public meeting was held on November 18, 2008 to present the proposed amendments to the Development Bylaw #29-B text attached to this Resolution; and

**WHEREAS** at the Public Meeting (November 18, 2008) some comments were raised and noted regarding the proposed bylaw; and

**WHEREAS** the comments from the Public Meeting were discussed at the Planning and Heritage Committee meeting on November 24, 2008.

**WHEREAS**. the Committee agreed that the proposed document now meets the requirements for amending the Development Bylaw;

**BE IT RESOLVED** that Bylaw #29-B (On-Site Small Wind Energy Systems), a Bylaw to amend Bylaw #29, the Stratford Zoning and Subdivision Control (Development) Bylaw, be hereby read and approved the first time. Bylaw #29- B (attached) shall be called "Part III.)

Councillor McMillan stated that this bylaw has been a long time coming and would like to commend Vahid for his extraordinary work on this bylaw. She added that there has been excellent communication and good input from the public.
