1. <u>CALL TO ORDER</u>

Councillor Emile Gallant called the September 9, 2009, Regular Monthly Council Meeting to order at 4:35 p.m. noting that both Mayor Jenkins and Deputy Mayor McMillan are out of the province and he will be chairing the meeting in their absence.

4. PRESENTATIONS

Presentation - Senior Volunteer of the Year Award Bus Gay

Councillor Gallant noted that this evening he and Councillor MacDonald have the honour of presenting the MacIntyre-MacDougall Senior Volunteer of the Year Award.

He noted that the large group of dedicated residents who volunteer their time and talent to the community are the key to the Town's success. One area that is a priority for the Town is the Seniors who have built our community, province and country.

This award was established to honour people who volunteer their time and talent to increase the quality of life of our senior population. One such person is long time resident and tireless volunteer Bus Gay. Bus is always working to make Stratford a better place and it is my great pleasure to present the third annual MacIntyre-MacDougall volunteer of the Year Award to Mr. Bus Gay - a very deserving recipient. Congratulations Bus.

A presentation was made to Bus and photos were taken. Councillor MacDonald stated that Bus is a great worker and volunteer, and he can't think of anyone would be more deserving of the award. Councillor MacDonald then asked Bus if he would care to say a few words. Bus thanked Council for the award noting that he doesn't attend very many Council meetings, but when he does attend, he always reminds Council that they must be doing a good job if no one is attending - because otherwise the chambers would be full.

Presentation from the Floor

Good afternoon Councillors. My name is David Johnston and my family and I have lived on the Mason Road for 40 plus years. I would like to thank you for this opportunity to speak to you about the problem of the oyster fishermen on the lower Mason Road.

We realize that the oyster fishermen have a right to make a living fishing oysters. However, this is a commercial fishing industry and they should have a proper place provided for them away from a residential neighbourhood. The oyster fishermen launch their boats from the lower Mason Road, but then travel up the river and out of sight to harvest their oysters. The majority of these fishermen are from the Tignish area. They are not even residents of our community.

As far as I can tell from reading the bylaws of Stratford, I could not set up a business in my neighbourhood that would cause bumper to bumper parking from the shore to the Mason farm gate and beyond. I would be required to have off street parking and I could have no more than two employees working at my home. The dwelling has to be occupied as a residence by the principal operator. There appears to be special permits issued, but one of the stipulations is that the business will not cause any hardship to surrounding property owners due to excessive noise, traffic congestion or other potential nuisances. As residents, we have to abide by the bylaws of Stratford, but it appears that the oyster fishermen can move into our neighbourhood and use our road for parking and not have to adhere to the bylaws of the town because technically the roads are owned by the province. The bylaws do nothing to address the issue of fishermen moving into the community and taking it over.

We, the residents of the Mason Road want the oyster fishermen removed permanently from our neighbourhood for the following reasons:

- 1. Unsafe for our children who play, walk, and ride bikes in the area.
- 2. The bus stop is blocked. The children wait on Starling Crescent for the bus and then cross over, as the bus driver has told them it is not safe to wait amongst the trucks.
- 3. Increase in traffic as they come and go all day long.
- 4. Speed.
- 5. Racing of vehicles two abreast.
- 6. Operations start about 4:00 a.m. until sundown.
- 7. Backing down the road to the shore. They could not see a child that might pop out of a ditch or driveway.
- 8. They turn in our driveways.
- 9. Noise of them coming and going, as there can be up to 30 trucks and trailers.
- 10. Unsightly would you like to sit and look at a nice view through old trucks and trailers? Would you like this in front of your house? We built here for the view.
- 11. Who would want to buy our houses and look at this mess. When and if the Mason's sell lots on that side of the road, it certainly will make them hard to sell when people know that the oyster fishermen will park in front of their house for the duration of the fishing season.
- 12. Daycare children and other walkers cannot walk up the road safely, as there is no place to step off with oncoming traffic approaching.
- 13. Wear and tear on our shore, as they drive on the shore and have been known to drive from the Mason Road to the Duffy Road on the shore.
- 14. The oyster fishermen block access to the sewerage pumping station.
- 15. There is no place for recreational boaters to park during this period.

This is our neighbourhood and we feel that we should have some say in what goes on in it. We did not knowingly move into a neighbourhood with a large commercial fishery going on. We were here first.

We do not want the ditch on the Mason farm side of the Mason Road filled in to make permanent parking for the fishermen. As far as I know, we aren't allowed to fill in our ditches anymore. There is a great run off of spring water on that side of the road each year. Even though culverts might be in place, I feel that this could cause serious flooding on our road.

We do not feel that the access to the shore on the lower Mason Road should be used for a commercial venture. It should only be for recreational access to the shore for the residents of Stratford.

We have put up with this situation since they were put off the mini farm in 2002. We hope we can count on your support to help us have the oyster fishing industry moved to a more suitable location. Thank you.

Councillor Gallant replied that Council is working with the province to try and find a solution, as we agree that it is a problem and we need to find a solution. He noted that our local MLA Alan McIsaac has asked to address the floor.

MLA Alan McIsaac took a moment to congratulate Bus Gay noting that he is a great advocate on this side of the bridge and he is glad to see him recognized.

Mr. McIsaac then addressed the fisher issue. He gave a bit of background information noting that the oyster fishery is two seasons. It runs from the May 1 until July 15 and again from September 15 until November 30. We are in a lull at the moment, but the fishers will be back. Mr. McIsaac stated that the fishers do have a right to fish, but the problem is how do they get to the water. My understanding of why they were put out of the mini farms is because they were accessing the water through a private entrance and that was closed off to them. So where do you find an access that is suitable, and of course Mason Road is very accessible. The problem then becomes the parking. Mr. McIsaac stated that Herb Mason was the first to bring the issue to him and informed him that the trucks and trailers are lined up on the road - at times 30 trucks. Mr. McIsaac stated that he met today with Minister Le Clair, Deputy Minister Gallant and a member from TPW on this issue. There was some discussion, as Mr. Johnston mentioned, about infilling the ditch, but that is not happening at the present time because we are looking for a real solution and it would not work for the land owner and future development possibilities. There are a few other sites that are not quite as accessible as the Mason Road, but are less populated. In closing, Mr. McIsaac stated that we do not have a solution yet, but we are definitely working on it.

Councillor Gallant added that we see the accesses as recreational accesses to our waterfront and the Town is committed to finding a long term solution to this issue.

She added that what was really impressive was the number of different nationalities present.

A complete written report was included in the package for Council to review. Councillor MacDonald gave a brief overview of the report noting that August was a very busy month. He noted that the McNeill Field for the Canada Games was in excellent condition and favourable comments were received.

Councillor MacDonald stated that officials at the Official Opening of the Cricket Field took the time to thank Jason Hughes for the work he did on the field, and Ron Fisher for setting up the Cricket Association.

b) Resolution RC004-2009 Recreation Infrastructure Improvements

Moved by Councillor Steve MacDonald Seconded by Gary Clow

WHEREAS the Town of Stratford owns and operates parks, playing fields and facilities which are available to the public for their use; and

WHEREAS the Stratford Recreation Commission has identified areas of improvement required for parks, playing fields and facilities in 2009; and

WHEREAS areas of improvement include the following: clubhouse at soccer complex has wheelchair accessibility; roof repair and painting to soccer clubhouse; provide fiberglass dugouts at soccer complex; minor field repair to soccer fields; and

WHEREAS total costs of upgrading and renewal of recreational facilities are expected to be \$56,000.00; and

WHEREAS total costs are to be cost shared between the Town of Stratford and federal and provincial governments.

BE IT RESOLVED that an application for funding to the Atlantic Canada Opportunities Agency's Recreational Infrastructure Canada (RinC) program in and the Island Community fund in the amount of \$56,000 to upgrade and renew facilities as aforementioned be hereby approved with the Town's 1/3 share of the funding to come from the 2009 capital budget and/or Parks Capital Reserve fund as necessary.

Recreation Commission. Councillor MacDonald noted that we had applied earlier, but had to re-apply, as we were informed that we are

only permitted to apply for one project at a time.
